GAME DAY INFORMATION AND START TIMES

Games will begin promptly at 6:30 pm (Playoff games could start at 6:45 with Conference Supervisor's approval). If either team is awaiting the arrival of their 8th player, a 15-minute grace period will be extended. When the 8th player arrives, the game **must** start. If and when the 9th and 10th players come, they can be added, as soon as they are ready, anywhere in the line-up that has not had an at-bat yet. If the grace period expires and the 8th player has not arrived, a forfeit is called against the shorthanded team.

April games will have 1 and 1 count. Starting May 1st all games will have a 1 and 1 count with an extra foul.

RESCHEDULING GAMES

When a game is cancelled, the home team manager and the visiting team manager will have until midnight of that day to schedule a make-up date and call it in to the Ken Gesseck (631) 355-9924 scoreline. If a date is not called in by midnight, the Conference Supervisor will schedule the make-up game for the first available Monday, Tuesday or Thursday that both teams are not playing, and when the home field is available.

MANAGERS ARE NOT TO CONTACT USSSA WITH SCHEDULE REVISIONS

GAME SOFTBALLS AND PLATE MATS

Two League sanctioned softballs are to be supplied for each game by the home team. Both teams are responsible for bringing a plate mat to the field. The home team is required to put out the plate mat. If they don't have their plate mat, then the visiting team is required to put out the plate mat. If the game is played with the visiting team's plate mat, they become the home team for that game. If both teams do not have a plate mat, then both teams receive a forfeit for the game. **No game should be played without a plate mat behind home plate.**

LEGAL GAME DAY CANCELLATIONS

Cancellations due to inclement weather must be made **before 3:30 pm**. The home team manager must notify the USSSA assigner Floyd Bassett at 631-582-4383. Home team manager is also responsible for notifying Away Team Manager and calling/texting Ken Gesseck (631) 355-9924 to report a cancellation before 3:30 pm. **'NO FIELD' is not a legal GAME DAY reason** for a cancellation. **The Home Team is responsible for securing an approved field or they will get a FORFEIT LOSS.** Cancellations not due to weather must be made 24 hrs. before game time.

ILLEGAL GAME CANCELLATIONS

If a game is cancelled for any reason other than inclement weather with less than 24 hours notice, the league will be billed for the entire umpire fee of \$50 for USSSA. That fee will be deducted from the home team's performance bond.

SCORE REPORTING

All scores are to be TEXTED in by the winning manager to the Ken Gesseck (631) 355-9924 before 9:30 pm on the night of the game. Failure to report a score on game night, or later than the 9:30 pm deadline will result in performance bond forfeiture (for the first offense) and a 14-0 forfeit against the winning team (for the second offense).

Please include a brief review of your game's umpire (his name or number) in this call as well.

MASK RULE

Reminder: All pitchers **MUST** be wearing a mask in order to be allowed to pitch, NO EXCEPTIONS!

All game night rule infractions, umpire no-shows or any other problems are to be reported to your Conference Supervisor that night by both managers.
